SHORT LINE CONNECTIONS

TO THE MEMBERS:

In connection with Appendix B, Code of Car Hire Rules and Interpretation—Freight (OT-10), attached for your information is a list of Short Line Railroads for whose account car hire is being reported direct to car owners by trunk line connections.

Those roads reporting car hire direct to car owners on behalf of their short line connections should review this Circular thoroughly, and report any listing that is not consistent with its current accounting procedures to csc@railinc.com.

Railroads granting or expiring this privilege under Appendix B, to new or existing short line should immediately report such to the Assistant Vice President, Business Services, at csc@railinc.com.
