#### **REN Web Overview**



- REN Web provides an easy-to-use interface to create and publish groups and dockets.
  - Created dockets are transmitted through REN Central to REN participants in the interline route.
- REN Web validates dockets using Industry Reference Files, Umler and Shipment Condition Files.
- Users are also able to search for any dockets that they are party to.
- REN Web ensures valid and timely auto rating is applied to revenue waybills for ISS.

### Why Create Groups in REN Web?



- You can easily reuse groups across multiple dockets for shipment, patron, geography and commodity groups.
- Groups save time from having to manually enter and look up to enter a large set of data.
- Groups ensure consistency across the industry all groups are public and open for use by any REN participant.

#### What is a PNDR?



- A set of four codes that identify a specific docket version:
- Proposer This code identifies the SCAC of the docket's creator.
- Number This identifies the docket control number as assigned by the REN Web user.
- Docket This code is a unique number automatically assigned to the docket by REN Web.
- Revision This number identifies the revision number of the docket.




