

## Release Notes for December 10, 2020 Umler System Release

The Umler system release scheduled for Thursday, December 10, 2020, includes functional enhancements to Umler which includes docket implementation work as directed by the Umler Committee to implement new elements, element changes/updates, as well as modifications to permissible values and business rules within the application.

Below are the complete details of this release.

- Element Updates (New Elements/Element Changes & Removals)
  - o 4-Pressure Receiver Equipped (B539)
    - Equipment Group(s): ALL
    - Update Element Name:
      - From: 4-Port Receiver Equipped
      - To: 4-Pressure Receiver Equipped
    - Update Element Description:
      - From: Identifies if the equipment is equipped with a 4-port air brake test receiver
      - To: Identifies if the equipment is equipped with a 4-pressure air brake test receiver
  - Lading Strap Anchor Equipped (B121)
    - Equipment Group(s): BOXC, GOND, FLAT
    - Update Element Description:
      - From: Indicates the equipment is lading strap anchor equipped
      - To: Indicates the equipment has fixed devices or design features which provide connection points for straps or bands securing the lading
  - o Adjustable Lading Strap Equipped (B281)
    - Equipment Group(s): BOXC
    - Update Element Description:
      - From: Indicates the equipment is equipped with an adjustable lading strap
      - To: Indicates the equipment has adjustable straps or a strap system used for securing the lading

      - To: Tare Weight (A259) value must be reported to the nearest 100 pounds
